Project Evaluative Criteria

The Steuben Area Economic Development Corporation (the “Agency”) will conduct a written **cost benefit analysis** and evaluate each project being considered for benefits using the criteria listed below:

- **Extent to Which a project will create or retain permanent jobs**
- **Estimated Value of Tax Exemptions to be provided**
- **Amount of private sector investment**
- **Likelihood of project being accomplished in a timely fashion**
- **The extent of new revenue provided to local taxing jurisdictions**
- **Inclusion of onsite childcare for employees or other benefits to support employee childcare needs**
- **Any other misc. public benefits that might occur**

Material Terms

In addition, the Steuben Area Economic Development Corporation will, at the time of project review, take into consideration material terms which will be used to determine if a project applicant has met the obligations required for the approval of incentives set by the board. These terms will be utilized by the board in setting and monitoring project benchmarks during the term of the incentives for the purposes of administering the EDC’s Policy for termination of benefits.

It is understood that the review will vary depending on project type and project specifics. The EDC has adopted specific “Evaluative Criteria” to be considered when reviewing each project type.

These criteria are adopted to provide board guidance when reviewing project applications. The board reserves the right to use additional measures and to gather additional information or data relating to evaluative criteria specific to individual projects.
